Clerk Report:

The Clerk reported on the new building status. Tunks Construction is getting ready to put the sheetrock up and then they will paint. He anticipates that he will have the building completed by the end of this month.

Water Report:

Water Loss 16.4%

Doug informed the Board that the pump at the south lift station needs to be repaired. He is currently running on one pump. He presented an estimate from Alliance Pump and Mechanical. After some discussion, Alderman Gibson made a motion, second by Alderman Baumgarden to repair the pump and to pay for the repairs using COVID funding. Motion passed 4-0.
