Consent Agenda:

Alderman Kull moved, and Alderman Stone seconded the motion to approve the consent agenda. The motion passed 3 - 0.

Bills: A list of January and February 2025 bills was presented for approval and payment. Alderman Stone moved, seconded by Alderman Kull, to approve the presented bill list. The motion passed 3-0. The Clerk reported that the City's electric payment to Ameren was not received until after the due date. The Clerk proposed that the City pay the electric bill to Ameren via ACH (Automated Clearing House) after each board meeting. This method would save the City money on postage, envelopes, and checks. All members present agreed to implement this payment process for Ameren Electric following each board meeting.

Public Comment:

Austin Ethington, a concerned citizen, proposed the idea of planting fruit trees at the City park, emphasizing its potential as a community resource. Alderman Stone encouraged Austin to provide more details at the next board meeting, while Alderman Kull suggested the concept of a community orchard, fostering a sense of community involvement in the decision-making process.

Mayor Report:

Mayor Bradford requested that a new office chair for the City Clerk be purchased. Alderman Kull has an extra office chair that she will donate to the City for the Clerk to use. Alderman Stone made a motion, seconded by Alderman Baumgarden, to purchase a new office chair for the City Clerk. The motion passed 3-0.

Clerk Report:

The clerk wanted to know if the board wanted to move the April board meeting to April 16th due to the election being one day before the regular board meeting. The Board agreed. The April board meeting will be on April 16th. The City budget meeting was set for March 26th at 6 p.m.
