Clerk Report:

The Clerk reported that a resident on Morrell Street has requested the installation of a dead-end sign due to a high number of drivers using the street as a turnaround. We have also received multiple complaints about dogs running loose in town, and letters have been sent to their owners regarding this issue.

Additionally, citizen Gus Larscheid has asked the City to repair his sidewalk, which was damaged. He expressed that he would prefer a more robust repair than simply applying a patch mix. In response, the Board has directed Doug to remove the cracked section and pour a new slab section with rebar reinforcement.

The Clerk reported that multiple complaints about dogs running loose in town have been filed. Letters were sent to the owner detailing the complaints, including their dates and times. The Board advised to continue sending letters to the owner.

Water Report:

Water Loss 10.6%. Doug reported that the city needs to obtain bids to replace the fire hydrant that was struck by a driver on Platte Street. Alderman Stone made a motion, seconded by Alderman Baumgarden, to directly solicit three bids in accordance with the city's procurement policy for the replacement of the fire hydrant. Motion passed. 3-0. The lawnmower needs repairs. Doug needs to call around and find someone who works on them.

Street Report:

Doug reported that he has been working on the streets as the weather allows.

Dust Control:

The Board agreed that dust control is not to be applied on City streets until the City Attorney creates a policy for the City to adopt.

New Business

Ordinance #2025-04 – Establishing a school zone on Clinton Ave.:

Alderman Stone moved to put ordinance 2025-04 on its first reading by title only, seconded by Stinson.
